Order

Whereas Sh. Vishwajeet Singh had represented on 26-11-2019 that he was senior to Neena Sharma, Hira Lal Bhat and Jeet Lal in the seniority issued in 2015 and 2018

Whereas Neena Sharma and Hira Lal had represented that they were promoted to the post of Clerk-cum-Librarian (later re-designated as Senior assistant) vide Order No. INF/J-601/2010 dated 4-11-2010 and Vishwajeet Singh was promoted as Katib(later re-designated as Senior assistant) vide Order No. INF/J-605/2010 dated 4-11-2010.

Whereas as per the Seniority lists issued vide Notification No. INF/J-1620-34/2017 dated 23-3-2018, Sh. Vishwajeet Singh was placed ahead of Neena Sharma and Hira Lal and the date of promotion of Sh. Vishwajeet was shown as 15-11-2010 and that of Neena Sharma and Hira Lal has been shown as 16-11-2010. Whereas the scrutiny of records clearly shows that Neena Sharma, Hira Lal Bhat and Jeet Singh were promoted on 4-11-2010 as Clerk-cum-Librarian now re-designated as Senior Assistant and Vishwajeet Singh was promoted on 4-11-2010 as Katib now re-designated as Senior Assistant, therefore the date of promotion mentioned in the seniority list issued vide Notification No. INF/J-1620-34/2017 dated 23-3-2018 does not hold ground.

Whereas as per Rule 24 of J&K Civil Services(CCA) Rules, 1956, the inter-se seniority of two or more persons appointed to the same service, class category or grade simultaneously will not withstanding the fact that they may assume the duties of their appointments on different dates by reason of being posted to different stations be determined by their relative seniority in the lower service class, category or grade. Since both the services are different i.e Clerk-cum-Librarian and Katib, who merged as one i.e. Senior assistants, the date of placement of the three in the lower grade is as under:-

3.	Jeet Singh	Junior assistant (3050-4590 now revised to 25500-81100)	19-11-2004	Promoted as Clerk Cum Librarian now revised to Senior assistant on 4-11-2010
4.	Vishawjeet Singh	Appointed as KCGA on 10-10-2006	10-10-2006	Promoted as Katib now re-designated as Senior assistant on 4-11-2010

Hence the claim of Sh. Vishawjeet Singh does not hold merit.

Likewise Sneh Lata, Anayat Ullah and Varinder Pal Singh who were placed higher in the tentative seniority list are placed after Sh. Vishwajeet Singh as they were promoted as Clerk cum Librarian now re-designated as Senior Assistant on 12-02-2011, 12-02-2011 and 23-09-2011 respectively. The representation jointly submitted by Neena Sharma, Hira Lal Bhat, Sneh Lata, Anayat Ullah and Varinder Pal Singh does not hold merit.
