- The appointees stands at S. No. 1 & 2 shall report to the Joint Director Information, Kashmir and the appointees figuring at S. No. 3 & 4 shall report to Joint Director Information, Jammu, Media Complex, near Vishal Mega Mart, Bahu Plaza, Jammu within a period of 21 days from the date of issuance of this order failing which the order shall be treated as cancel ab-initio.
- The appointees shall be allowed to join only on production of the following certificates (in original);
 - All Academic qualification certificates.
 - Matriculation/date of birth certificate
 - Health certificate from the concerned District Medical Board.
 - Permanent Resident Certificate issued by the competent authority.
 - Certificates from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under the self-employment scheme has been obtained by the appointees.

3. The appointment of the candidates shall further be subject to the following conditions:
- The appointees shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about their character and antecedents is received from the Inspector General of Police, (CID), J&K or any other competent authority to whom a reference shall be made by the Joint Director Information, Kashmir and Joint Director Information, Jammu respectively, they shall have no right or claim to their appointment
 - Genuineness of the academic qualification/technical and PRC certificates from the concerned issuing authorities shall be verified.
4. The salary of the appointees shall be drawn and disbursed to them only after the satisfactory reports in respect of condition (i) and (ii) above are received in their favour.
5. If, on verification, the certificates produced by the appointees are proved fake or forged, their appointment shall stand cancelled ab-initio.
6. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated. 24.12.2009 and SRO-202 of 2015 dated.30.06.2015
7. The appointment of the above candidates shall be subject to the final outcome of writ petition(s) if any, pending in any court of the competent jurisdiction.


