



Subject: Rationalization of Staff/Streamlining the Establishment.

Order No. INF/ 73 of 2019
Dated: 27.06.2019

In supersession to all previous orders issued with regard to the adjustments and in order to streamline the establishment of this Directorate, the following detachments/adjustments are hereby ordered with immediate effect:-

- i. Mr. Fayaz ul Rashid Incharge Cameraman Jammu Division presently working in this directorate and drawing the salary against the post of AIO (State Cadre) shall draw his pay against the post of his own discipline in divisional Cadre Jammu (i.e Cameraman, Dy Dir (PR), Jammu). However, he will continue his present assignment till darbar moves to Jammu.
- ii. Mr. Hamidullah Buchoo, Senior Assistant Divisional cadre Kashmir is hereby adjusted in the Directorate of Information against the identical time scale post of steno-typist retaining his lien and promotional prospectus in his parent cadre (i.e Divisional cadre Kashmir) as recommended by I/C Deputy Director (PR), Directorate, till further orders or till the selection is made by the SSB against the post of steno-typist, whichever is earlier.
- iii. Mr. Hira Lal Bhat, Senior Assistant, Joint Director Information, Jammu Division whose pay is being drawn against the post of Senior Assistant/Steno-typist in this Directorate of Information and has been adjusted by the Joint Director Information, Jammu against the post of his own discipline shall continue his present assignment in this Directorate as recommended by I/C Deputy Director (PR), Directorate till darbar moves to Jammu. However, the Accounts Officer shall issue LPC of the official from this Directorate.
- iv. Mr. Ghulam Mohammad Sheikh, Chauffeur, Kashmir Division presently attached in the Directorate, is repatriated to his parental cadre of Joint Director Information, Kashmir (FPU, Srinagar) against the post Chauffeur already held by him. However, he will continue to work in this Directorate due to paucity of Drivers, till alternative arrangements are made and his salary shall be drawn as Chauffeur in the Kashmir Division, against his parent cadre post.
- v. Mrs. Sunita Bhat, Head Assistant, Directorate presently attached in the KBI, New Delhi, is adjusted in the KBI, New Delhi against the post of AIO presently vacant till further orders or till the post of AIO is filled by competent authority. This arrangement is necessary due to the shortage of staff at KBI, Delhi.
- vi. Mr. Mukhtar Ahmad Beigh, Assistant Cameraman of Kashmir Division, presently attached in this Directorate, is hereby detached and repatriated to his parental cadre ie. JD, Kashmir Division. However, he will continue present assignment but will draw his pay against the post already held by him in his parental cadre.
- vii. Mr. Mohammad Latif Parrey, Incharge Sr. Assistant, Kashmir Division presently attached in the Directorate shall continue to work on the present assignment keeping in view shortage of staff in the Directorate and his salary shall be

drawn against the post of Steno-typist till further orders or till the selection of the posts of steno-typist is received from SSB, whichever is earlier, retaining his lien and promotion prospectus in Kashmir Division.

- viii. Mr. Gagan Singh Jamwal, Incharge Sr. Assistant whose pay and charge allowance was being drawn against the lower post of Jr. Assistant is adjusted against the post of his own discipline i.e. Sr. Assistant caused vacant due to the adjustment of Sh. Hirla Lal, Sr. Assistant in his parental cadre by the Joint Director Information, Jammu whose LPC shall be issued by the Accounts Officer.
- ix. Mr. Wajat Hussain, Assistant Cameraman, Directorate of Information whose salary was being drawn on the lower post of Videographer shall draw his salary on his own parent cadre post i.e Assistant Cameraman, Directorate of Information &PR.
- x. Mr. Manzoor Abdullah, I/c ~~Film~~ Production Assistant, Directorate of Information whose salary was being drawn on the lower post of Camera Assistant shall draw his salary on his own parent cadre post i.e I/ ~~Film~~ Production Assistant, Directorate.
