Pending confirmation by the State Level Departmental Promotion Committee, the following Senior Assistants are hereby placed as Incharge Information Assistants and Junior Assistant as Incharge Senior Assistants with charge allowance as admissible under rules with immediate effect, in their own pay and grade subject to the following conditions:-

- That this arrangement is made keeping in view the acute shortage of experienced staff
- That this is purely and temporary arrangement to carry on the day-to-day activities of the department in a more vigorously and transparent manner;
- That this arrangement shall not confer any rights upon any incumbents to claim permanent absorption against the post unless other eligible in terms of the rules and norms governing the departmental services.
- That placement shall take effect only when the concerned official occupies physically the post and attain higher responsibilities. They shall have no claim in case of they applies for modification of posting order.
- That they shall have to join at their respective places as shown against each hereunder within a week's time from the date of issuance of this order failing which the arrangement shall be deemed to have been cancelled abinito in respect of the defaulter and next official in the queue shall be considered for the placement.
- That no charge allowance shall be admissible any Incharge Information Assistant and Incharge Sr. Assistant unless and until he/she physically joins new place of posting.
